

**NPDES GENERAL PERMIT FOR STORM WATER DISCHARGES FROM LARGE AND SMALL
CONSTRUCTION ACTIVITIES Co-OPERATOR AGREEMENT**

All contractors and subcontractors identified in the plan to perform construction related work intended to disturb soils at the Site that may affect the implementation of the SWPPP but who will not be Co-permittees must sign the certification statement given below:

"I certify by my signature below that: a) for Sites that disturb 10 or more acres, I participated in a pre-construction conference onsite or, when allowed, offsite with the individual who is responsible for the operational control of the Storm Water Pollution Prevention Plan (SWPPP); and b) I understand the terms and conditions of SWPPP as required by the general National Pollution Discharge Elimination System (NPDES permit number SCR100000 issued to the Owner/Operator of the construction activity for which I have been contracted to perform construction related professional services. I understand that I, and my company, as the case may be, am legally accountable to the SC Department of Health and Environmental Control (DHEC), and Pickens County, under the authorities of the CWA and the SC Pollution Control Act, and Pickens County Stormwater Ordinance 356, to ensure compliance with the terms and conditions of the SWPPP."

The signatory requirements of South Carolina's Water Pollution Control Permits Regulation 61-9.122.22, as provided in Appendix C (k) of Permit No.: SCR100000, are applicable to each contracted entity that must sign the contractor's certification statement. Upon signing the certification, the contractor is a co-permittee and becomes accountable to SCDHEC and/or Pickens County to ensure the terms and conditions of Permit No.: SCR100000 are implemented. All co-permittees are subject to enforcement actions if Permit No.: SCR100000 conditions are not met. Enforcement actions may be taken against any specific Co-permittee or combination of Co-permittees, with consideration given to the party responsible for the violation. The owner/operator submitting the NOI shall retain all contractor certifications for at least three years after a contractor has completed work at the site. Copies of all contractor certifications and a copy of Permit No.: SCR100000 shall be retained on the site of the construction activity. The owner/operator of the construction project covered by Permit No.: SCR100000 shall make all contractor certifications available upon request to Pickens County and/or SCDHEC.

Copies of all contractor certifications shall be kept with the SWPPP. For construction sites that disturb 10
acres or more, the first monthly report or copies of the first month's inspection forms submitted by the
Owner/Operator after construction begins on this facility must include the original and one copy of all
operator and other contractor certifications. If additional operators or Co-permittees are added later on, the
original and one copy of the additional operator or Co-permittee certification must be submitted along with
the monthly reports or copies of the inspection forms submitted after the signing of the certification. For
construction sites that disturb less than 10 acres, the Owner/Operator of the facility covered by this permit
shall make all contractors certification available upon request.
